The North Carolina Department of Transportation is requesting bids for the installation of detour signing and traffic control devices for scheduled maintenance or construction activities and permanent signing on state maintained roads in Bladen, Columbus, Cumberland, Harnett and Robeson counties. The Contractor is to furnish labor, equipment, and traffic control.

**The availability date for this project is March 1, 2012. The completion date is December 31, 2012.**

Sealed bids must be received in the Contract Officer's Office at the Division 6 office at 558 Gillespie Street, Fayetteville, N.C. by 10:00 a.m. February 1, 2012. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:


